



Education in 2023 started out with a long ABC course which is the basic boating/safety course plus several weeks to teach Coastal Navigation. We had three students signed up for the class and that was a disappointing start for the year. Our next class, Celestial Navigation

was cancelled due to an insufficient number of students, and the same for the scheduled Sail class.

It appears that we are back to the pre-pandemic setting, where it was difficult to get students to sign up for classes. ## **Squadron Chaplain**



#### MARITIME LAW CORNER

(Ed note: apparently, and gratefully, no laws were broken by any Members leading up to this issue!)

Update Re: The Conception Dive Boat Fire

Many of you have read my previous posts regarding the dive boat tragedy that occurred off the coast of Santa Barbara on September 2, 2019.

Following a 10-day trial, a federal jury last week, on November 6, 2023, four years after the incident, found scuba dive boat captain Jerry Boylan was criminally negligent in the deaths of 34 people killed in a fire aboard the vessel in 2019, the deadliest maritime disaster in recent US history.

According to a press release from the U.S. Attorney's Office for the Central District of California, Jerry Boylan, 69, of Santa Barbara, was found guilty on Monday of one count of misconduct or neglect of ship officers — an offense known as "seaman's manslaughter."

Per the release, the crime carries a maximum penalty of 10 years in federal prison.

"This ship captain's unpardonable cowardice led to the deaths of 34 lives on Labor Day 2019," said attorney Martin Estrada. "As the jury found, this tragedy could have been avoided had Mr. Boylan simply performed the duties he was entrusted to carry out. We hope that today's verdict brings some solace and closure to the victims' loved ones."



The US attorney's office said Boylan failed to post the required roving night watch and never properly trained his crew in firefighting. The lack of the roving watch meant the fire was able to spread undetected across the 75ft boat.

District Judge George H. Wu scheduled sentencing for Feb. 8. Boylan remains free on a \$75,000 bond.

The Conception was anchored off the Channel Islands, 25 miles (40km) south of Santa Barbara, when it caught fire before dawn on the final day of a three-day excursion.

Thirty-three passengers and a crew member perished, trapped in a bunkroom below deck. Among the dead were the deckhand, who had landed her dream job; an environmental scientist who did research in Antarctica; a globe-trotting couple; a Singaporean data scientist; and a family of three sisters, their father, and his wife.

Boylan was the first to abandon ship and jump overboard. Four crew members who joined him also survived.

The verdict comes more than four years after the 2 September 2019 tragedy, which prompted changes to maritime regulations, congressional reform, and civil lawsuits.

## Lessons Learned from the US Coast Guard – 2023

#### SAFETY LESSONS FROM THE US COAST GUARD - NOVEMBER

My editors granted me permission to skip publishing my article in October, for which I was grateful, as my wife and I had planned a canal cruise in Burgundy - Central France. It was not our first time on a French canal, as we've 'cruised' on the Canal du Midi four years ago. Still, it was a different experience. We slowly cruised for two weeks down Canal du Nivernais, navigating under many low and narrow bridges and through 53 locks, operated by human power! I enjoyed getting physically involved, assisting the French lockkeepers, while the Burgundy landscape is beautiful. However, post-COVID pandemic, many of the advertised markets, restaurants, and wineries did not survive.



The French navigation rules on their Inland Waterways are different from our home rules, navigating our Inland Waterways. Canal du Nivernais runs parallel to, and sometimes joins, the Yonne River with WEIRS (low-head barriers across the width of a river to manage the flow of the river) that aren't very visible from a distance. So, I did some research, as there was no 'Rules and Regulations' handbook that came with our boat. The sound signals are somewhat the same, though rarely used. The signs to aid us in how to choose a safe path under a bridge, around a weir, or entering a lock, and what areas to avoid on the river, are unfamiliar. Of course they are crucially important. Here's a question: would you know where to find our Inland Aids to Navigation? Try https://www.uscgboating.org/images/486.PDF.







. In September we looked at operating your vessel (INLAND) through a Narrow Channel while you must stay within the channel to navigate safely. So, I asked: another vessel is crossing your course from starboard to port, and you are in doubt as to her intentions. What signal is appropriate? One of my



regular readers chose D, 'are required to back down.' Based on his logic that 1. Backing down does not mandate leaving the channel, 2. The starboard boat has the right of way. 3. It would not force the port vessel out of the channel. And 4. The starboard vessel should sound 1 blast (34.c.i. I am approaching from starboard) though I did not give this us that option!

Much as I liked this answer, here was my response (respectfully): Hmmm, good reasoning. My 'hint' was Narrow Channel so looking at the Table of Content of the USCG Navigation Rules that's Rule 9. (a) is downbound, (b) is < 20 meters, (c) is fishing and (d) is **crossing**. Rule 9 (d) says that a vessel shall not cross if that impedes. For the 'in doubt' part: INLAND says in Rule 34 that you *shall* use the sound signal. Therefore, my answer is B, must sound the danger signal.

Now for next month's challenge. It is not too often that we see cones as dayshape on a vessel. But they are still part of our Rules and Regulations. What's important is the direction of the apex (top or highest part, forming a point). So, I'll ask two questions. 1) what type of vessel or operation is indicated by a vessel



showing two cones with the apexes together, and 2) what type of vessel is displaying one cone with the apex down?

1) and 2) Α Sailing vessel under power. В Fishing (trawling) vessel. C Minesweeping operation. D Dredging underway.

So, find me the **two** Rules, and the **two** answers, and what is an *important* exception to this Rule. To learn more, I hope you consider taking a course from our Americas Boating Club Oceanside. We can shorten the course if you only want to get "The Boating Card". We are preparing to teach the Engine Maintenance Course. We are also in full swing teaching an "On the Water Boating Program" with P/D/C Shawn Goit, JN as the instructor in the classroom and on the water. #### **Coming Soon: Cruising Under Power and Sail 2023**

Fully revised, Cruising Under Power and Sail 2023 supersedes Cruising and Cruise Planning 2013. The new course reflects the changes to boats, technology and cruising
